#### PCQS Update

Practices should have received the attached letter advising that the PCQS contract has been extended to 30th September 2024 to allow for the current tariffs to be renegotiated. We recognise that the current tariffs have not kept pace with increasing practice costs and that many are in fact loss making. Through our ongoing positive engagement with the ICB team, they are aware of this and that, if services are not to be cut, tariffs need to be appropriately uplifted to reflect the increased cost of delivering services and that is what we are collaboratively working towards. We are disappointed that our negotiations could not be completed in time for the new financial year but are reassured that any agreed new tariffs should be backdated to 1st April 2024.

### EMIS business continuity mode testing

Practices are advised to ensure that they test their EMIS business continuity mode on a quarterly basis as this can provide back up in the case of an issue with accessing EMIS. Instructions on how to do this can be found here. If your EMIS business continuity mode is not functioning, please raise a call with EMIS in the first instance. If practices are not being supported by EMIS to get this resolved, please let the LMC know, and we can raise on your behalf.

### **GP Appointments in Kent & Medway February 2024**

The LMC has updated the 'GP Appointments in Kent & Medway 'poster to help practices evidence to patients the amount of work being carried out, and the pressures faced, by general practice, and the steps patients can take to help themselves manage their care. Practices may wish to display this in their waiting rooms or add to their websites and social

media sites. The data is sourced from NHS digital. The next update will be published soon after the next release of GP appointments data.

## South East Complaints Hub

In 2023 it was agreed that NHS Frimley Integrated Care Board (ICB) would host the South East Complaints Hub to manage complaints about primary care services on behalf of the six ICBs within the Southeast Region. NHS Frimley ICB has recently changed their headquarters and with this change, the postal address of the South East Complaints Hub has also changed.

From Monday, 1 April, the postal address is now:

#### **General Practice Alert State (GPAS) National Reporting Dashboard**

The national GPAS reporting dashboard has been published and shows the pressure general practice is under. Last week Kent & Medway practices reported **GPAS Red/Opel 4.** Thank you to practices that continue to provide input into GPAS on a weekly basis. The information you provide is invaluable in evidencing the pressure general practice is operating under. The GPAS information from the national dashboard will be used by the BMA and feed into contract negotiations.

Submissions continue to be completely anonymised. The LMC is not able to identify individual practices from the submissions. The only data that is shared with either the ICB or other stakeholders is aggregated at HCP or Kent and Medway level. The more practices that take part in GPAS, the more robust the evidence will be. **Collecting this data is assisting the LMC in illustrating operational pressures in general practice. The report takes less than 5 minutes to complete each week.** 

We would encourage every practice to submit a report on weekly basis and to also provide comments and feedback. Furthermore, if you are experiencing acute operational pressures please do get in touch with either the LMC or the ICB to seek support
