COVID-19: understanding the impact on BAME communities

A summary of stakeholder insights into factors affecting the impact of the COVID-19 pandemic on black, Asian and minority ethnic (BAME) communities has been published by Public Health England. An accompanying letter to the Equalities Minister from the Chief Executive of Public Health England sets out the recommendations for action outlined in the report.

Resumption of optical services in England

Optical practices holding a general ophthalmic services (GOS) contract have been <u>sent this letter</u> which sets out the next steps for delivery of NHS optical services in England, as the NHS moves into the second phase of the COVID-19 response.

Personal Protective Equipment (PPE) Portal Order Limits

In Tuesday's Update we encouraged practices to sign up to the new PPE Portal so they can place orders for PPE. We have now been informed that, after considering the stock and demand levels, the Department for Health and Social Care doubled the order limits for Type IIR masks on the portal this week.

Each practice can now order a combined pack, containing 100 (previously 50) IIR masks, 200 aprons and 200 pairs of gloves, per week or up to this amount of separate items
