Infection prevention and control

# Good ventilation to minimise risk of Covid-19 transmission

A recommendation from the environmental sub-group of SAGE earlier this year was for local consideration to any enhancements that could be made to improve ventilation in healthcare premises. National infection prevention and control guidance was updated to include this.

Portable fans, either with or without blades, should not be used during an outbreak of infection in any healthcare setting as micro-organisms accumulate in the motors and on the blades. They should be removed from all clinical areas to mitigate the risk of transmission of Covid-19.

Air conditioning units should be healthcare recommended and properly maintained, meet water safety requirements, cleaned regularly and engineers consulted to ensure external air source is appropriate. Natural ventilation reduces risk of transmission and can help to cool rooms during high weather temperatures. During these times, organisational heatwave policies should be referred to which will encourage usual heat control measures e.g. curtains to remain closed, outside shutters/shade on windows etc and also ensuring advice is in line with health and safety recommendations.

## Digitising care homes - expressions of interest

With winter pressures coming there is a timely opportunity to expand the use of digital technology to provide remote care and monitoring to patients who are residents in care homes, including for those with Covid-19 symptoms.

Kent and Medway CCG and partners have secured funding for around 100 care homes to be issued with an iPad and improve access to digital care for their residents. Participating care home's staff will be trained by <a href="https://example.com/The Design">The Design</a> and Learning Centre on how to use the iPads and support digital literacy.

The support programme will help care homes to:

- use video consultations and online consultations so your patients can access primary care remotely
- improve care coordination the aim is to support care homes to move to using virtual multi-disciplinary teams (MDTs) through online meetings (such as Microsoft Teams) with GPs, health and care teams, and
- support communication between care homes and practices by making sure care homes use NHS mail.

We will also support practices to make sure the programme runs smoothly and not create extra workload from your point of view.
