IT Update

Today's IT disruption to almost all practices in Kent and Medway was caused by a fire at a data centre in London that affected IT systems across the country. We believe that connections have been restored to almost every surgery and your systems should be working again - if this is not the case please contact the IT Helpdesk.

This was obviously an unwanted opportunity to test business continuity plans. We will be reviewing how the system responded to further reduce the impact if such a failure should occur again.

Clinical advice and support

Patient Transport Service (PTS)

G4S will reapply eligibility criteria for all patients booking PTS in Kent and Medway from Tuesday 1 September 2020. This is in line with the NHSE third

phase letter of 31 July which moved the incident level from Level 4 (national) to Level 3 (regional). Generally speaking this should allow G4S to manage capacity in line with restart requirements.

This may mean that some patients who accessed PTS during the Level 4 Covid-19 response may not meet the reintroduced eligibility criteria - G4S will manage any patient complaints received. Patients can feedback/complain to G4S by ringing 0800 953 4139 or on the <u>Kent and Medway PTS website</u>.

Update on stroke services review

On Tuesday 25 August we received notification from the Court of Appeal that permission has been refused for an appeal against the judicial review ruling on the stroke services review. This decision draws a line under the legal process challenging the decision to implement three hyper acute stroke units in Kent and Medway, and brings the NHS closer to being able to make improvements to stroke services. A press release has been issued.

KCHFT Integrated MSK Services (Physiotherapy, Orthopaedics and Chronic Pain) face to face clinics return in September

KCHFT's Physiotherapy, Orthopaedic and Chronic Pain Services continued to receive referrals and successfully delivered services virtually over the past few months. From September patients may also be seen in face to face clinics if clinically required.

Clinic locations:

DGS/Swale – Gravesham, Sittingbourne and Sheppey

West Kent – Maidstone and Sevenoaks

East Kent – Ashford, Tenterden, Folkestone, Dover, Deal, Thanet, Canterbury and Whitstable

MSK Physiotherapy - following an initial virtual assessment patients requiring a face to face assessment can be booked into clinic. Patients can still undertake virtual/on-line education and information sessions (knees and spines) and virtual ESCAPE knee programmes. Rehabilitation programmes will now be a mixture of face to face and virtual sessions tailored to individual patient need.

Community Orthopaedic Outpatient Clinics – patients will continue to have an initial virtual assessment followed by a face to face appointment if clinically required. Throughout September those patients waiting for joint injections are being seen in their nearest clinic. Additional clinic venues will be phased in throughout September and October to also accommodate patients requiring a face to face assessment.

Community Chronic Pain Services (west Kent, east Kent and Swale) – this service is successfully delivering most elements of the biopsychosocial pathway virtually, including Pain Education Sessions and Pain Management Programmes; Pain assessments and reviews; meds management; Psychology; movement advice and streaming live Tai Chi and Mindful Movement sessions. Face to face Specialist Pain Physiotherapy clinics and Alexander Teaching clinics will commence in October and face to face Pain Management

Programmes in November for those unable to undertake a virtual programme. The service will also be starting the new Opioid Management Programme in east Kent and west Kent in October (start date deferred from April).

Cyberstalking

Supported by Look Ahead, Protection Against Stalking and The Cyber Helpline are partnering together to provide a unique cyberstalking clinic service in west Kent. Appointments can now be booked for the first clinic between 12 noon and 8pm on Wednesday 23 September 2020.

If you have a client who is being cyberstalked and needs advice and support they can meet with a specialist stalking expert from Protection Against Stalking and a cyber security expert from The Cyber Helpline. Each session will be 45 minutes allowing our experts to understand what is happening, identify risk, produce a safety plan and provide immediate advice on how to improve their cyber security. The clinic will demystify technology and help clients feel safer and more confident when using technology.

The clinic will be held in the Tonbridge area, clients will be advised of the exact location in pre-appointment communication.
