### **Enhanced NHS 111 service launched**

From today (Thursday 1 October), people calling 111 in Kent and Medway will have access to a wider range of healthcare professionals (GPs, paramedics, nurses, mental health professionals, dental nurses and pharmacists) through the new Clinical Assessment Service (CAS).

This will mean patients have a wider range of expertise available to assess their symptoms over the phone, issue prescriptions directly and book people into onward care appointments if appropriate.

This is the result of a new five-year contract for the 111 service, which was awarded to South East Coast Ambulance Service NHS Foundation Trust (SECAmb) as lead provider, in August 2019. SECAmb is working in conjunction with not-for-profit social enterprise Integrated Care 24 (IC24) to deliver the service across the region.

The launch of the CAS follows significant work from our urgent care teams across the system, who worked through a robust procurement process and then saw the plans paused

as the whole system responded to Covid-19. The original go-live date of 1 April 2020 was postponed due to heightened demand brought on by the Covid-19 pandemic, with SECAmb's interim contract extended to bridge the spring/summer season allowing the team to focus on the immediate response.

The launch of the CAS is coinciding with the phased rollout of NHS 111 First across Kent and Medway. This separate improvement to the service, which allows people to be booked directly into the local emergency department, or suitable urgent care service, was soft launched in Medway and Swale in September, with our other three integrated care partnership areas across Kent and Medway following later this autumn/winter.

# E-learning for health and care staff on recovery and rehabilitation

People who recover from Covid-19 infection often continue to display a range of physical and psychological symptoms that require therapy and support. This new <u>interactive COVID-19 recovery and rehabilitation e-learning programme</u> from Health Education England aims to provide health and care staff with strategies and techniques to manage key symptoms experienced by people recovering from Covid-19. Four 20-minute e-learning sessions cover breathlessness, exercise, cough and fatigue. The programme is included in the continuing professional development (CPD) portfolio for health and care staff.

### Personalised Care Institute launch event

You are invited to the launch event of the <u>Personalised Care Institute (PCI)</u> in the South East region on Wednesday 7 October, 2-3pm.

The PCI is a new training hub for all health and care staff to access the very latest in personalised care training and development. It is convened by the Royal College of General Practitioners in partnership with and funded by NHS England and Improvement, with support from other Royal Colleges, key professional organisations, providers and patients. It offers a wide-range of flexible and accredited courses from a variety of providers and will support staff to gain the knowledge and confidence to provide personalised care to their patients.

PCI will play a vital role in helping to deliver on the NHS Long Term Plan commitment to ensure 2.5 million people receive personalised care by 2024.

Kent and Medway Prehab are pleased to announce a new programme available to cancer patients in Kent and Medway. The Kent and Medway pre-habilitation programme, funded by the Kent and Medway Cancer Alliance, is an innovative programme that helps prepare new cancer diagnosed patients for treatment using a multimodal intervention. The programme aims to improve the fitness of cancer patients, both physical and mental through personalised exercise plans, nutrition interventions and psychological support.

The programme draws expertise from appropriate areas of public health to assist patients' health improvement journey. These include quit smoking support, advice on alcohol, access to local physical activity sessions and awareness of supporting healthy weight programmes.

# Coronavirus tests requested for staff or members of their household

Please note that our colleagues in the hospital sector are only able to provide Coronavirus tests to those who fit the current testing criteria. Only primary care staff or members of their households who are symptomatic for Coronavirus will be tested. The recognised symptoms for Coronavirus are:

- a high temperature;
- a new, continuous cough (coughing a lot for over an hour; or three or more coughing episodes in 24 hours)
- a loss or change to sense of smell or taste.

Tests must take place within five days of exhibiting symptoms.

At the moment healthcare staff and their households cannot be tested for any other reason. This includes requests for precautionary (i.e. asymptomatic) testing, or when only other cold and flu symptoms such as runny nose or a sore throat are present. This applies to all household members, including children.
