#### **GP Staff Training Team (GPSTT) Update**

The LMC GPSTT Oversight Board met last week and heard from the team at Invicta Health Learning that the number of face-to-face courses now taking place has continued to increase. However, there is recognition that in many cases virtual training is still more convenient for attendees and usually more cost effective. Therefore, we will continue to offer both types of training as appropriate. Most PCN staff are now able to access the service and there are currently 119 PCN staff that are active users of the Learning Pool. The LMC GPSTT are working closely with the Training Hubs to try to ensure that together we are making use of every available training resource to benefit General Practice across Kent & Medway.

## KMPT and NELFT Interface Meetings

The LMC held their regular liaison with KMPT and NELFT. Medication prescription requests were discussed and the LMC were assured that GPs should not be being asked to initiate prescriptions of specialist medication, if this does occur KMPT would like to know so they can investigate, GPs can contact KMPT via the email address kmpt.clinicalqueries@nhs.net (this is not for referrals). KMPT and the LMC agreed to work together to produce a webinar to update GPs of the changes within the KMPT teams and familiarise GPs with their Community Mental Health Teams, we will keep you posted.

The issue of blood sample and ECG requests was discussed, KMPT may ask practices to undertake ECG/phlebotomy and if the practice agrees it was clarified that the result is not the responsibility of the GP, KMPT will provide an email for the result to be sent back to in the case of ECG for interpretation by their requesting clinician, and for blood tests KMPT provide the request form and so the result automatically goes back to the requesting clinician. Practices can

claim for ECG/phlebotomy under PCQS. KMPT have made progress with the issue of referral rejection having undertaken a pilot in West Kent. They have provided an update which is below.

#### **Routine Referrals into KMPT**

The Community Mental Health Framework, which seeks to integrate care for patients with mental health problems across the county is beginning to be implemented. As part of this work KMPT Community Mental Health Teams (CMHT) have piloted a joint screening process with Live Well Kent for all referrals coming into the KMPT CMHT, where it is agreed which agency is best placed to care for the patient. Patients are then referred directly to the appropriate service, their care is not delayed and referrals are not passed back to the GP. This has worked extremely well and there has been very positive patient feedback on this work. This process is only for patients who are referred to the KMPT CMHT.

An information sharing protocol is in place to ensure robust Information Governance. We would therefore be most grateful if, when you need to refer a patient to KMPT CMHTs you are able to inform the patient that this will be a multi- agency screening and their care may be provided by a partner organisation if it is felt they would better suit the patient needs.

NELFT updated the LMC on their current position. There remains a backlog of children waiting for diagnostic assessments for ADHD and Autism. NELFT are working to employ additional staff to undertake the assessments to reduce waiting times, there continues to be challenges in finding workforce. The Eating Disorder Service has seen a 110% increase in referrals during COVID, NELFT have employed a consultant paediatrician onto the team to assist in the care of this group of patients, specifically with interpretation of investigations. The issue of blood requests was discussed with NELFT, as these services are not provided to children in general practice NELFT will be exploring alternative solutions.

## K&M GP Board Summary/PCN Incorporation Workshop

The Workshop was led by accountancy expert Andrew Leal, MacIntyre Hudson(MHA) and legal expert Nils Christian, DR solicitors. This presentation demonstrated the potential benefits of setting up a limited company to sit alongside a PCN. It is a model that has been adopted by around 40 PCNs so far across England. The proposal is that a limited company is setup and owned by the practices within a PCN. The limited company then has several advantages over a flat or lead practice PCN model for employing ARRS which include:

- 1. A single organisation to employ ARRS staff simplifying structure. On the ground ARRS can still work alongside practice staff.
- 2. ARRS / other shared staff employed through this company can enable a cost sharing agreement to be set up which significantly reduces VAT risk.
- 3. Governance Limited companies come with a set governance structure improving financial transparency, enabling a consistent HR / holiday policy for all ARRS.
- 4. Reduced liabilities Ltd companies have limited liability so any potential costs from staff disputes etc would not call on owners own capital. This is different to traditional GP partnerships and therefore other PCN models where the liability is un-ending and can call on partners own assets. It was pointed out that there is a real risk in the fact that current PCN models are actually partnerships at will with unlimited liability.
- 5. Other contractual work outside of the PCN DES could be run through the company, expanding GPs opportunities to provide more services for their communities.
- 6. NHS pension scheme can be made available to ARRS staff employed through these organisations.

The risks appear to be limited it was acknowledged there is a financial cost to setting up a company and ongoing accountancy. There is also a need for GP partners to spend time setting things up.

## Health or adult social care? Where to refer guidance for GPs

Kent LMC met with the KCC safeguarding/social team, regarding the new referral forms they have rolled out. They explained the difficulties of being able to follow up patients without the form which ensures they have contact details and consent to contact the patient. However they did agree that referrals should not be rejected if the information was incomplete. They also agreed that a GP dictating their concerns, and then admin pasting into form, ticking any boxes they are able to, was acceptable to them.

### Ongoing provision of PPE

A new personal protective equipment (PPE) website has been launched, ensuring continuity of PPE distribution to frontline health and care staff, and other eligible users. Practices can continue to access free of charge until 31 March 2023 or until infection prevention and control (IPC) guidance is withdrawn or significantly amended.
