#### Why should practices consider becoming Tier 2 visa sponsors?

To help practices employ locally trained GP ST3 as they complete training, we want to highlight consideration of practices becoming Tier 2 Visa sponsors. Many of our GP trainees completed undergraduate training abroad and are currently working here as GP trainees with a Health Education England type 2 visa. Once they have completed training any prospective employing organisations (including GP practices) need to be Tier 2 visa sponsors. We know this process is complex, costly and takes a few months to complete and are looking at ways of supporting practices through this process. #### Medical Appraisal Guide 2022

The updated Medical Appraisal Guide 2022 has been released. This is a national document which forms a guide and should be read in conjunction with the GMC guidance for appraisal and revalidation. Changes implemented in the pandemic continue, the emphasis on quality rather

than quantity, as such CPD hours are not stipulated. It is advised that evidence should cover your entire scope of practice. There is recognition that discussion in the appraisal holds equal weight to written evidence.

The Role of Organisations are mentioned, with guidance that organisations should where possible assist the doctor to collect GMC required supporting information, organisations are encouraged to have transparent data collecting mechanisms. This is a document agreed by all the Royal Colleges which remains advisory. The LMC feel this could prove challenging for practices and particularly for our locum workforce.

The MAGMAF is being phased out and replaced by the AoMRC Medical Appraisal Template 2022. We are aware of colleagues who choose to use MAGMAF as their preferred appraisal tool. This has been raised with the regional team and we will update you when we have further information.

### Diabetic Eye Screening updates

#### Using Spectra PM

Eye screening is an important part of a patient's diabetes care. Spectra PM allows you to view your patients journey during their annual screening appointment and download their result letters. The software contains everything you need in one place to able to view and support your diabetic patients for their eye screening. #### **New to Practice Programme (NTPP) and Fellowships Programme**
