Bank Holiday arrangements for Monday 19th September

The letter from NHS England confirms the arrangements for primary care services for the 19 September 2022. These are summarised below.

General Practice

• Practices have permission to close on 19 September 2022.

Extended Hours Access (EHA)

- Practices have permission to cancel EHA provision scheduled for 19 September 2022.
- PCNs must make up cancelled EHA provision by offering additional appointments within a two-week period, unless otherwise agreed by the commissioner.

Covid Vaccination Programme

- Scheduled care home visits for high priority visits should go ahead as planned.
- Maintenance of scheduled clinics are strongly encouraged, particularly where there is a high population need.
- Providers should speak with the ICB should there be a need to flex local arrangements.

Communications with patients

- Patients must be notified of cancellations and appointments rescheduled.
- Where planned appointments are going ahead it is important this is also confirmed with patients.

Managing Workload

Data published by NHS Digital shows that practices in Kent and Medway are working harder than ever, delivering more patient access than before the pandemic. Despite this, the demands on practices are still growing, with other parts of the system calling on general practice to do more and more.

Kent LMC hosts a variety guidance for practices advising how they can prioritise their workload. This guidance is not about restricting services. It has been collated to support practices to provide safe, quality and accessible general practice services, when they are being prevented from doing so by requests to undertake inappropriate or unresourced work.
