REMINDER: Kent LMC Elections 2023-2026: Call for Nominations

As the NHS emerges from the pandemic, and now faces unprecedented demand and backlogs alongside transformation, arguably it has never been more important that the views and insights of grass roots GPs are heard in discussions that will impact on patients, practices and practice staff.

With the changes of the commissioning landscape and the greater powers for Integrated Care Boards this demands a strong frontline GP voice. LMCs are perfectly placed to coordinate and advocate for the consistent and authentic voice of general practice, bringing together individuals, practices, Primary Care Networks, and federations alongside other providers.

The current term of office of the members of the Local Medical Committee comes to an end on 31st March 2023, and we are now commencing the Election process for members to the new Committee for the term of office from 1st April 2023 – 31st March 2026.

Whether you are an experienced LMC member who knows the system well, returning to work from maternity leave or a career break, recently qualified, or a long qualified GP with no previous

experience in a medical leadership role, your expertise is welcome and we encourage you to stand. Your perspective and ideas are valuable to your LMC. If you are a new LMC member, you will be supported by colleagues to develop your knowledge of the wider healthcare landscape. ICB message Future requirements for Messaging, Online Consultations and Video Consultations, Dr Krishan Bhanot, Clinical Lead for Digital, NHS Kent & Medway

Kent and Medway are looking at future requirements for digital technologies GP Practices currently use and supplied by the ICB. We are aware that these tools have become part of the everyday processes we have come to rely on.

Between January 2021 and December 2022, we sent around 100 million SMS text messages which included Floreys, video consultation links, patient campaigns and questionnaires. The products have also inspired our teams to develop innovative ways of working and design new processes and workflows.

We are keen to find single solutions that work for everyone. We also are keen to hear a wide range of views, and to that end, practices are invited to complete the digital survey.

Please take the time to complete this carefully and take the opportunity to highlight any particular needs your Practice and locality may have to improve joint working and integrated care.

The ICB is taking a need led approach to understand requirements at GP level, PCNs and localities to inform the development approach in the best interest of patients. Please give specific examples of how this might apply to one particular product vs another.

As we all know, technology moves very quickly so we are keen to work with companies that continue to innovate and update.

Digital Firearms Marker enabled in EMIS practices from 6 February 2023

A new Digital Firearms Marker will help make firearms licensing safer. The marker will be deployed on 6 Feb 2023 for practices using EMIS Web (EMIS) systems.

GPs should add the appropriate SNOMED code to a patient's record when they receive notification of a firearms certificate application or when a certificate is granted. This will now create a Digital Firearms Marker on a patient's record.

Creating a peer network for practice/PCN digital champions

The Kent & Medway digital team, chaired by GP Clinical Lead for Digital at Kent & Medway ICS, Dr Mayur Vibhuti, is aware that there are a host of technologies and software that have been deployed into General Practice in the last couple of years. The training to use these products has not necessarily caught up – so the team aims to set up a virtual learning program to address this. In November 2021, an evaluation was undertaken to assess the level of Digital Literacy across primary care in Kent and Medway and to prioritise areas for development.

The digital team are looking to identify a member of staff from each practice across Kent & Medway to represent them as a Digital Champion. We will connect all these people via a Kent & Medway peer learning group and provide training sessions to upskill them all, so they maximise the software benefits to you at the practice and share best practice / innovative ways of working.

Improving communication between General Practice and East Kent Hospitals

As I am sure you are aware the LMC is working with EKHUFT to improved interface between General Practice and Hospital Colleagues. We have managed to negotiate a new plan which involves identifying the key departments which are in most need of improvement. Interface issues may involve work not best suited for General Practice including prescription requests to GPs, onwards referral request to GPs, follow up of tests / investigations initiated in hospital etc. Once identified we have agreed to audit a random selection of correspondence to identify the nature of these issues and then develop an improvement plan.

GPAS Weekly SitRep

GPAS was implemented to allow General Practice to report the state of resilience across Kent & Medway so that system leaders can understand the pressures being experienced and compare them to those in the rest of Primary and Secondary Care.

Every week Practices submit their assessment of their current state into a central database using data from an EMIS report. Submissions are **completely anonymised**; the LMC is not able to identify individual practices from the submissions. The only data that is shared with either the ICB or other stakeholders is aggregated at HCP or Kent and Medway level.

The more practices that take part in GPAS, the more robust the evidence will be. Collecting this data is assisting the LMC in illustrating practice pressures.

The report only take 5 minutes to complete each week. We would encourage every practice to submit a report on weekly basis and to provide comments and feedback. The LMC is able to assist with getting practices started on reporting. Tell us how you are - primary care wellbeing survey

NHS England commissioned the Institute for Employment Studies to conduct a study of the wellbeing of the primary care workforce over a time period of three years. This short survey is the sixth and final in a series of surveys, and will ask staff to reflect on their personal wellbeing as well as the functioning of their team and their experiences of working in their role.

We are asking people to please complete this survey and share with teams – it's important that we get a wide and varied dataset so that we can continue to develop wellbeing interventions and support for the workforce. We are particularly keen to improve our understanding of the experience of people with protected characteristics and from underrepresented groups. Any help sharing this would be greatly appreciated.
