IT Failures

We are really sorry that you have had to endure the recent IT failures and for some this happened twice last week resulting in no clinical system or appointment book.

We have been making representations to the ICB since March about the failures, which are not concluded yet, and we have followed this up today with the most recent failures that have occurred over the last week.

We have asked the ICB to support practices and to understand what this actually means in general practice, including the patient safety concerns these failures create. We have asked the ICB to share their business continuity plans so that we know what support and communications we should expect and when.

We know that it has been such a difficult time for you all, and we hope that we can get some additional support. We will be back in touch asap. In the meantime we thank you very much for continuing to support your patients to the best of your abilities given such circumstances.

Kent & Medway General Practice Board 24th May 2023

At the meeting of the General Practice Board last week we discussed **shared care**, and what this actually means, as interpretations from colleagues can be mixed. By simply transferring care to General Practice without consent does not constitute Shared Care.

Dr Ash Peshen confirmed there is work looking at the Out of Hospital offer. There has been a Procurement PIN release with workshops looking at community services provision and what that could look like going forwards.

The GP Access Recovery Plan instructs ICBs to report to its Board in the Autumn on the Secondary to Primary Care inappropriate work transfers. A group with acute Medical Directors, the ICB and the LMC is being led by Dr Steve Fenlon and has made a positive start.

General Practice Alert State (GPAS) - Submission to National Dashboard

Thank you to all practices that continue to provide a weekly a submission. The information you provide is invaluable in evidencing the pressure general practice is operating under.

The Kent GPAS report is now included in a National GPAS reporting dashboard and we will need to submit our Opel Status (GPAS state) into the national dashboard by 2pm every Thursday so we would ask that all practices complete their GPAS submission by noon on Thursday of each week.

Submissions continue to be completely anonymised. The LMC is not able to identify individual practices from the submissions. The only data that is shared with either the ICB or other stakeholders is aggregated at HCP or Kent and Medway level. The more practices that take part in GPAS, the more robust the evidence will be. **Collecting this data is assisting the LMC in illustrating operational pressures in general practice. The report takes less than 5 minutes to complete each week.**

We would encourage every practice to submit a report on weekly basis and to provide comments and feedback.

Life after CCT Pensions and Tax/Accountancy - An update from the experts for new to practice General Practitioners Wednesday 28 June 1-2pm

Please join the Kent LMC, Andrew Leal, a partner at MacIntryre Hudson, and Paul Gordon, Head of Medical Specialist Wealth Planning at Atomos, for a lunchtime virtual update on Wednesday 28 June 1-2pm, to inform you about the NHS pension scheme and tax / accountancy working independently as a GP

Andrew will look at the tax issues relating to working as either a salaried GP, a locum or a partner and whether a limited company may be beneficial. He will also look at what GPs need to do via PCSE online to ensure superannuation contributions are correctly collected and some of the key issues to consider if contemplating becoming a partner in a practice.

Paul will look to run through the current NHS Pension arrangements and implications as you move from a trainee into general practice. He will cover general financial planning including the likes of mortgages, protection and even wills, and can be quizzed on all areas of finances.
