Care Quality Commission (CQC) fees reimbursement

To receive reimbursement of your 2023 to 2024 CQC fees, please send a copy of your CQC invoice along with evidence of full payment and the completed claim form to **kmicb.gpcontracting@nhs.net**. If you send this information anywhere else, it will not get paid. Once we have received your documents they will be processed, and payment will be added to the next available payment template. Please note that reimbursement will be made on evidence of full payment only and not part payment. If you have chosen to pay your CQC fees by monthly direct debit, then please send your claim form to us when you have paid in full. Business Rates demands 2023/24

Please can practices send copies of the 2023-24 rates demands to kmicb.gpestates@nhs.net as soon as possible as we have noted that half of our practices have not yet sent them in. Once received we will forward to GL Hearn for approval and confirmation that all refunds have been accounted for. Please include your proof of payment in the email.

Update: Removal of the panic button in EMIS Web

EMIS has confirmed that practices can request that the Panic button remains available for their organisation beyond Friday 29th September 2023 and have published the link to the opt in form which is now available on EMIS Now here. Requests must be received by Friday 15th September 2023 to avoid the Panic Button being removed on Friday 29th September 2023. A confirmation email will be sent once the request is received.

Organisations who request the Panic Button to remain available, will be able to request that it is subsequently disabled at any time. EMIS will not accept requests for the functionality to be reactivated once it has been disabled.

Citizen's Access to Records

Whilst the BMA is exploring a legal challenge to the imposition of the automatic switch on of access to records form 31st October 23, practices are still being advised to prepare their practices and staff for the switch on. IT Training for practice staff - update from SCW

SCW GP IT Training are pleased to announce the launch of our GP Practice IT Training Needs Survey, valid for 2024-25. We are commissioned by your ICB to provide clinical system and Microsoft training to your staff, at no cost to your practice. Most of our training is delivered in 2-hour sessions via MS Teams, and we have a duty trainer available each working day who can answer quick queries and/or dial-in to work through any issues with you.

For staff who are new to the NHS we have "Primary Care IT Induction" (aimed at practice staff) and "Insight to General Practice" (aimed at ICB staff, but all are welcome). Our "Introduction to the NHS App" is a useful overview of how the App can help patients and practices and the "Prospective Record Access" webinar explains how a practice should consider setting their EMAS Manager configuration in preparation for the roll-out of online record access for patients (if you haven't already gone live).

General Practice Alert State (GPAS) - Submission to National Dashboard

Thank you to all practices that continue to provide a weekly a submission. The information you provide is invaluable in evidencing the pressure general practice is operating under.

The Kent GPAS report is now included in a National GPAS reporting dashboard and we will need to submit our Opel Status (GPAS state) into the national dashboard by 2pm every Thursday so we would ask that all practices complete their GPAS submission by noon on Thursday of each week.

Submissions continue to be completely anonymised. The LMC is not able to identify individual practices from the submissions. The only data that is shared with either the ICB or other stakeholders is aggregated at HCP or Kent and Medway level. The more practices that take part in GPAS, the more robust the evidence will be. **Collecting this data is assisting the LMC in illustrating operational pressures in general practice. The report takes less than 5 minutes to complete each week.**

We would encourage every practice to submit a report on weekly basis and to provide comments and feedback.

EKHUFT/ICB/LMC Interface

The LMC met with Rebecca Martin of EKHUFT on 8 June 2023 as part of a regular meetings to discuss primary to secondary care interface.

With the advent of NHS England's recent Access Recovery Plan for General Practice the group reflected it was an opportunity to review the format of the meetings, including inviting the ICB to the meetings in light of their responsibility to approve the Trust's interface improvement plans.

An issue that has been frequently raised at these meetings has been that the PALS team has been advising patients when they have been seeking to expedite their referral. EKHUFT have agreed to use this poster, produced by the LMC, when communicating with patients. Practices are asked to inform EKHUFT via ekh-tr.gpinfo@nhs.net of any instances where patients have been advised to contact their practice by PALS for such a letter.

EKHUFT is also involved in the Electronic Referral Optimisation System (EROS) and will be going live in the next 2 to 3 months. The rollout will begin small and gradually expand across specialities over the following months. It is expected that EROS will takeover Advice and Guidance due to its improved functionality.

There will be lots of online support available to help users fully utilise EROS. The LMC also secured the assurance that there would be mechanism for users to bypass EROS where patients do not fit the pathway.

Mike Bedford provided an update on the various digital workstreams currently underway across the Trust. Key to note was the work to standardise EDNs across the Trust; and to introduce EPS. Further updates will follow in the future.

Life after CCT Pensions and Tax/Accountancy - An update from the experts for new to practice General Practitioners Wednesday 28 June 1-2pm

Please join the Kent LMC, Andrew Leal, a partner at MacIntryre Hudson, and Paul Gordon, Head of Medical Specialist Wealth Planning at Atomos, for a lunchtime virtual update on Wednesday 28 June 1-2pm, to inform you about the NHS pension scheme and tax / accountancy working independently as a GP

Andrew will look at the tax issues relating to working as either a salaried GP, a locum or a partner and whether a limited company may be beneficial. He will also look at what GPs need to do via PCSE online to ensure superannuation contributions are correctly collected and some of the key issues to consider if contemplation becoming a partner in a practice.

Paul will look to run through the current NHS Pension arrangements and implications as you move from a trainee into general practice. He will cover general financial planning including the likes of mortgages, protection and even wills, and can be quizzed on all areas of finances.
