Managing patients with gender dysphoria update

Please find attached letter that was endorsed by Kent & Medway GP Board on the 12th July highlighting serious concern regarding the lack of commissioned non-specialist services for individuals with gender dysphoria and the burden it is placing on GPs.

Changes to NHS complaints process: primary care services

From 1 July 2023, NHS complaints and community pharmacy, optometry and dental commissioning will be hosted by NHS Frimley Integrated Care Board (ICB) on behalf of all ICBs across the South East. This means that how people make a complaint about GP services is changing. If a person does not want to complain directly to a GP practice, rather than contacting NHSE, they can contact the complaints team via new contact details below:

Out of Area Patients – clarification of ICB comms

The ICB published a process for practices to follow when seeking to remove patients that are registered outside of their practice boundary, from their list. This was communicated in the 'K&M General Practice Update' on 27th June. We are aware it has caused confusion for practices as to whether this applies to patients who are moving address and moving outside of the practice's boundary. To clarify this process **does not** apply in these circumstances and practices **do not need notify the ICB** that they have advised the patient they will need reregister with another practice due to moving to an address outside of the practice's catchment area.

Manage Your Mind Workshops - Introductory Sessions (Virtual)

Kent Local Medical Committee have teamed up with Manage Your Mind to offer practices an exciting opportunity. We are holding free virtual introductory sessions open to any practice member wishing to learn more about the planned face to face events. The introductory sessions are being held 1-2pm on Thursday 20 July, Thursday 7 September and Thursday 14 September. These will give individuals an opportunity to understand more about the programme and experience some of the techniques first hand. The exclusive 1 day programme events will be held in person across Kent and Medway and are available to all practice staff. They will start in September through to November 2023 and will be a multi-professional programme. Sessions will focus on improving mental and emotional well being using powerful breathing exercises and mindfulness techniques. The cost of attendance is £80 but the LMC will share the costs with practices, reducing the cost per participant to £40. We will roll out with four one day sessions this year and we will aim to provide further sessions in 2024 according to demand.

Manage Your Mind offers individuals an opportunity to invest in themselves, to rest, to re-centre, to re-focus and to re-energise. Participants are likely to benefit from learning new skills, breathing techniques, guided meditations and processes that help calm the mind. Studies have shown that when practiced regularly, they help improve sleep, reduce stress, depression and anxiety and improve the quality of life.

NHS Pensions: training session for practice managers and HR leads

General Practice Alert State (GPAS)

Thank you to all practices that continue to provide a weekly a submission. The information you provide is invaluable in evidencing the pressure general practice is operating under.

The Kent GPAS report is now included in a National GPAS reporting dashboard and we will need to submit our Opel Status (GPAS state) into the national dashboard by 2pm every Thursday so we would ask that all practices complete their GPAS submission by noon on Thursday of each week.

Submissions continue to be completely anonymised. The LMC is not able to identify individual practices from the submissions. The only data that is shared with either the ICB or other stakeholders is aggregated at HCP or Kent and Medway level. The more practices that take part in GPAS, the more robust the evidence will be. **Collecting this data is assisting the LMC in illustrating operational pressures in general practice. The report takes less than 5 minutes to complete each week.**

We would encourage every practice to submit a report on weekly basis and to provide comments and feedback.
